

**Terms and Conditions
(Distributor and Customer)**

The Automatic Delivery Programme (ADP) is an optional programme by which a Distributor or Customer may receive Nu Skin and Pharmanex products on a monthly or bi-monthly schedule by placing a standing order to be charged against his/her credit card or debited regularly from a bank account. The policies below apply to NSE Advantage and upon signing you agree to abide by the Advantage ADP Terms and Conditions.

- A. I attach a valid VISA, MasterCard, Eurocard or Switch number along with the expiry date and authorise debits from my account for the products that I order and any other handling or processing fee that may incur. I understand that the personal data I provide, which is stored electronically is necessary for the performance of this contract. The Company will not use the data for any other purpose.
- B. I understand and agree that the products selected will be sent to me at the address listed monthly or bi-monthly as I have indicated unless I notify the Company in writing of a change. The quantities, processing date and method of payment I have selected will not be changed or substituted by the Company without my prior written notification. Please note extra shipping charges may be incurred for non-notification of address amendments.
- C. I understand and agree that I will be charged £4.11 (inc VAT) should I removed any product from the Advantage ADP and as a result the value of the ADP decreases.
- D. As a **Distributor** I understand and agree to order a minimum of 50 PV (before discount) continuously as part of this Advantage ADP.
- As a **Customer** I understand and agree to order a minimum of one (1) LifePak or one (1) LifePak Essentials Super A continuously as part of this Advantage ADP.
- E. I understand that the Company retains the right to reformulate the products or adjust prices during the Advantage ADP period.
- F. I understand that the Company reserves the right to adjust and amend the terms of this contract. Notice of such adjustments and amendments will be published at least 30 days before made effective.
- G. I understand that this Advantage ADP will be terminated without notice, if the payment method I have indicated is expired, cancelled or otherwise terminated. The Company will try to contact me on the listed contact information before cancelling the ADP.
- H. This Advantage ADP will last for an indefinite period, unless terminated in accordance with sec. G above or cancelled in writing by myself. The Company will discontinue the shipments within 30 days from receiving the cancellation.

Distributors Only

- I. My Distributor Agreement (DA) with the Company still applies and this form only supplements the DA. If the DA is terminated for any reason, this Advantage ADP will be terminated as a result. Products ordered under the Advantage ADP may be returned in accordance with the DA (Policies and Procedures section 7.4), but refunds are subject to commission verification and recalculation. This may effect the ultimate amount of commissions paid to the Distributor.

Customers Only

- J. You have the right to return purchased products within 14 days from delivery and be fully refunded, provided the packaging of the returned products is unbroken.

Both Distributor and Customer will receive the following benefits:

- Delivery Months 1 – 6: ADP Starter Pricing, 10% off price
- Delivery Months 7 – 12: ADP Loyalty Pricing, 15% off price
- Delivery Months 13+: ADP Loyalty Plus Pricing, 20% off price.

Products and packages already discounted do not qualify for ADP discounts.
