



# PRODUCT PURCHASE AGREEMENT— ISRAEL

This Product Purchase Agreement (herein the "Agreement") constitutes a contract between \_\_\_\_\_ ("Wholesale Purchaser") and Nu Skin Israel Inc. branch office (herein the "Company"), a corporation duly authorized and existing under the laws of the state of Delaware, U.S.A.

I.D. # \_\_\_\_\_, acknowledge that I have read and accept all terms and conditions set forth as follows:

1. I, the Wholesale Purchaser, have read and understood the Independent Policies and Procedures of the Company (including International Business Policy, Product Exchange, Buy-back, and Retail Customer Refund Policies) regarding my independent business activities as an Independent Distributor of the Company in the Israel.
2. If the Wholesale Purchaser is not a citizen of the Israel (ie. an International Sponsor), he or she certifies discovery of and compliance with (prior to submitting this agreement or conducting, sponsoring, or promoting any independent product division business in the Israel in any form) all immigration, visa, employment, and registration requirements of the Israel respecting the transaction of any Wholesale Purchaser's independent product division business in the Israel. In addition, Wholesale Purchaser certifies he or she will discover and comply with all applicable laws, regulations, rules, tax requirements, and other due demands of the relevant authorities of the Israel.
3. Wholesale Purchaser is not an employee of the Company. The Company is not sponsoring Wholesale Purchaser's employment or business activities in the Israel. Wholesale Purchaser is liable for and will bear all taxes and levies respecting its independent business and furthers agrees to indemnify the Company against any and all liability arising from noncompliance with its duties and obligations.
4. Wholesale Purchaser accepts the sole responsibility to conduct his or her independent product division business lawfully within Israel. Accordingly, Wholesale Purchaser releases and agrees to indemnify The Company and any associated product division Company, and their officers, directors, agents, and employees from all liability arising from any of Wholesale Purchaser's acts or omissions within the Israel.
5. The Wholesale Purchaser may send products purchased from The Company as gifts to personal contacts outside the Israel, provided these gifts are properly declared and approved by customs. Wholesale purchasers are responsible for understanding and complying with all customs requirements.
6. Wholesale Purchaser certifies that any products it purchases for resale purposes from The Company in the Israel, will be resold at retail only within the Israel.
7. Wholesale Purchaser acknowledges that any violations of the terms of this Agreement may result in termination of his or her eligibility to purchase The Company products in the Israel, and/or any other disciplinary action deemed appropriate by The Company under the terms of its then current Independent Distributor contract with Wholesale Purchaser.

8. This Agreement shall be governed exclusively by the laws of the State of Israel as to all matters, including but not limited to matters of validity, construction, effect, performance and remedies. The Courts of Tel-Aviv shall have sole jurisdiction over all matters relating to this Agreement.
