



PRODUCT PURCHASE AGREEMENT—USA

This Product Purchase Agreement (“Agreement”) is between _____, whose address is: _____, Distributor ID _____ (“Purchaser” or “I” or “me”), and Nu Skin Enterprises United States, Inc., a Delaware corporation (“Company”). The term “Nu Skin” may be used as a reference to the Company and its affiliated companies.

When I agreed to the terms and conditions of the Distributor Agreement, I agreed that I could purchase Nu Skin products at wholesale for resell in the country in which I am a Nu Skin distributor (“Resident Country”). I understand that I may also sponsor new distributors outside of my Resident Country in other countries that Nu Skin has officially opened and is doing business (“Authorized Country”). I understand that in consideration for the right to purchase Nu Skin products from the Company in the United States, I am subject to the following terms and conditions, and I agree that:

- (a) I am an independent distributor and have either (i) executed a hard copy of the Distributor Agreement, or (ii) agreed to its terms online; I have read and understand the terms and conditions of the Distributor Agreement and the Policies and Procedures of my Resident Country.
- (b) **The amount of each product that I may purchase from the Company is limited to a quantity appropriate for personal use in one month, and I may only use such products to become familiar with them, to demonstrate them to potential new distributors in the United States, or for personal use. I further agree that I must either (1) personally pick the product up in the United States from the Company’s distribution center, or (2) have it shipped to me at an address in the United States. I CANNOT RESELL ANY OF THESE PRODUCTS IN ANY AUTHORIZED COUNTRY, INCLUDING THE UNITED STATES.**
- (c) Before purchasing any Nu Skin products in the United States, I agree to read and abide by the Policies and Procedures, product exchange, refund and buy-back policies regarding my independent business activities as a Distributor in the United States.
- (d) I will comply with all applicable laws, regulations, rules and tax requirements, including all immigration, visa, and registration requirements of the United States. I release and agree to indemnify the Company and its affiliates, and their officers, directors, agents, and employees from all liability arising from any claims related to my activities in the United States.
- (e) I acknowledge that I am not an employee of the Company and the Company is not sponsoring my visit or business activities in the United States.
- (f) I am responsible for complying with all customs requirements, fees, and taxes if I bring products purchased for personal use in the United States back to my Resident Country.
- (g) I acknowledge that any violations of the terms of this Agreement regarding product purchases for personal use in the United States may result in the termination of my right to purchase products in any Authorized Country, and/or any other disciplinary action deemed appropriate by the Company.
- (h) If my distributorship is a corporation, partnership, limited liability company, or any other business entity, I am authorized to sign on behalf of the distributorship and bind it.
