Paris Incentive Trip Qualification

Qualification Criteria :

1. Achieve 3000GSV every month¹ (within qualification period) and create 2 new Executives² in your first generation and 1 person gets to join an all expense paid trip to Paris.
2. Achieve 3000GSV every month¹ (within qualification period) and create 4 new Executives² in your first generation and 2 persons get to join an all expense paid trip to Paris.

¹ Upon completion of qualification criteria, upline executive must meet 2000GSV every month up to the month of the incentive trip.

² Newly created Executives must be from Singapore and must not have been a previous Executive within the qualification period. All sales volumes for newly created Executives must be from Singapore, including LOI months.

Newly created Executives must also maintain 3000GSV for 3 consecutive months, immediately upon promotion to Executive title and within the qualification period.
