

ageLOC Boost™

如新港澳限時預購活動條款及條件

1. 當您遞交訂單時，即表示您同意接受與美國如新企業香港分公司（其與其關聯公司合稱「如新」或「本公司」）所訂立之本條款及條件所約束。如在文中有任何沒有定義的詞彙，其定義應與品牌專員協議書、如新政策與程序、銷售獎勵計劃及適用於購買人原居市場的相關文件的詞彙意思一樣，該等定義並被納入本文件之條款及條件的一部分。
2. 本條款及條件適用於在香港及澳門舉行的 ageLOC Boost™ 如新港澳限時預購活動（「本活動」），本活動僅適用於香港及澳門如新品牌專員。於本活動中，本公司會出售「ageLOC Boost™ 亮澤彈潤套裝」（“套裝”）予符合本活動購買資格的品牌專員。

「ageLOC Boost™ 亮澤彈潤套裝」售價為港幣 2,400 元，銷售業績(“SV”) 250，CSV 1,954(適用於香港品牌專員) / 澳門幣2,472元，SV250，CSV2,012.62(適用於澳門品牌專員)，並只會以套裝形式出售，套裝內包括以下產品：

- 1 x ageLOC Boost™
- 3 x ageLOC Boost™ 光感瞬活精華

有關以上套裝的分享獎金請參考於「Office」內或「星享城 – 個人中心 – 我的事業」內的資料。

3. 購買資格

要獲得於本活動中購買「ageLOC Boost™ 亮澤彈潤套裝」之資格，您必須是如新港澳的品牌專員，還要符合以下要求，

- 於 2020 年 11 月 1 日至 2020 年 12 月 1 日維持或晉升成為港澳品牌代表或以上名銜之品牌專員，每個品牌專員帳戶最多可購買 3 套「ageLOC Boost™ 亮澤彈潤套裝」；

4. 購買日期及時間

- 2020 年 12 月 9 日中午 12 時正至下午 7 時正於星享城(適用於香港品牌專員)；或 2020 年 12 月 9 日上午 11 時正至同日下午 7 時 30 分於澳門分銷中心(適用於澳門品牌專員) 進行訂購；

5. 購買不是必須；庫存及零售

- (a) 您明白「ageLOC Boost™ 亮澤彈潤套裝」的購買並非是必須的，並且您不會因招募他人參加本活動而獲得獎金的。只有在您購買「ageLOC Boost™ 亮澤彈潤套裝」及成功收貨後，且您須符合如新銷售獎勵計劃及政策與程序的規定及要求時，本公司才會向您支付獎金。此外，請自行負責財務問題並務實地經營您的品牌專員帳戶。不要為了參與本活動或如新事業而產生債務。

7. 使用他人的品牌專員帳戶購買「ageLOC Boost™ 亮澤彈潤套裝」

您明白如您以另一位品牌專員的品牌專員帳戶訂購「ageLOC Boost™ 亮澤彈潤套裝」, 您必須於訂購前已獲得該品牌專員有效簽署的產品訂購/信用咭授權表格, 並獲該品牌專員同意如新可收集、使用及披露其個人資料, 以及轉移其個人資料到香港及澳門及這些地區以外的第三方或如新的關聯公司, 作與本活動相關的用途。您同意當本公司按政策與程序第 2 章第 3.9 節的規定向您要求提供該書面授權時, 您會將該書面授權提供予本公司。

8. 提貨或送貨

- (a) 若是於 2020 年 12 月 9 日於本活動中訂購的「ageLOC Boost™ 亮澤彈潤套裝」, 您可選擇於如新生活體驗館或旺角分銷中心(適用於香港品牌專員)或澳門分銷中心(適用於澳門品牌專員)提貨, 或以送貨方式領取(只適用於香港市場), 或到智能櫃提貨(只適用於香港市場)。

- (b) 送貨方式訂單則於 2020 年 12 月 23 日前, 按照訂購時所提供的香港送貨地址或所選擇的智能櫃交付。本公司或其生活體驗館或分銷中心的地址均為無效之收貨地址。如選擇到智能櫃提貨, 在產品到達智能櫃後, 您將會收到由智能櫃發送之SMS通知, 請根據通知內的指示於期限前到您所選擇的智能櫃提取「ageLOC Boost™ 亮澤彈潤套裝」。請注意, 香港離島區域和偏遠區域的送貨時間需額外多加三（3）個工作天。

您瞭解若因您在訂購時所提供之送貨地址有誤又或是在與您確認送貨日期及時間後仍無法把

9. 限量、限購

- (a) **限量。** 您明白及同意我們不能保證你於本活動中一定能夠購買得到「ageLOC Boost™ 亮澤彈潤套裝」。香港出售的「ageLOC Boost™ 亮澤彈潤套裝」數量有限，未必有足夠數量以滿足您的訂購需求。所有「ageLOC Boost™ 亮澤彈潤套裝」售完即止。

10. 訂購程序及付款方法

- (b) **付款貨幣和信用咭授權。** 「ageLOC Boost™ 亮澤彈潤套裝」的價格以港幣計算。若使用信用卡付款，您授權本公司從您所指定的信用卡收取您所訂購的「ageLOC Boost™ 亮澤彈潤套裝」之全部貨款及其他與此相關的所有費用，包括運費。如本公司未能從您指定的信用卡中扣除相關款項，本公司會取消您的訂單而無需向您發出通知。如您選擇以他人之信用卡帳戶付款，您確認該持卡人已同意您使用他/她的信用卡，並得到該持卡人之書面同意。您確認該持卡人已同意如新為執行本活動所述事項的目的而收集、使用和披露其於本活動上之個人資料。

11. 個人資料的收集

本公司及本公司的關聯公司並不保證「ageLOC Boost™ 亮澤彈潤套裝」的收件人能將「ageLOC Boost™ 亮澤彈潤套裝」進口至任何國家。特別是嚴禁在台灣市場內或向台灣市場銷售或出口「ageLOC Boost™ 亮澤彈潤套裝」。「ageLOC Boost™ 亮澤彈潤套裝」的購買者或收件人均有個人責任遵守所有適用的進口、海關及牌照之法律及法規，並自行承擔因此而產生之所有關稅、稅項、牌照、申報費用，以及任何其他就有關您進口「ageLOC Boost™ 亮澤彈潤套裝」到其市場所產生的支出、費用及收費。因此，您同意賠償及保證本公司及/或本公司的關聯公司免於承擔因您違反本條款或本活動的條款和條件而導致的所有損失、損害、民事處罰、索償、支出、費用及收費。

13. 爭議

您同意任何因本條款及條件而產生或與之有關的爭議受中華人民共和國香港特別行政區（“香港”）的法律管轄並解釋，且同意接受香港法院的非專屬管轄。

14. 其他

- (a) 您購買及使用「ageLOC Boost™ 亮澤彈潤套裝」受本公司的政策與程序所約束，如有違反，本公司有權按照政策與程序採取任何適當的行動，包括但不限於紀律行動。
- (b) 如新可隨時更新或修改本條款及條件而無需事先發出通知。基於這個原因，您應於購買「ageLOC Boost™ 亮澤彈潤套裝」前審閱本條款及條件。如本條款及條件跟本公司的政策及程序或其他相關文件有任何差異，均以本條款及條件為準。
- (c) 如新的名稱及商標乃如新專有的並為如新所擁有。本活動之所有內容皆受如新的版權保護。本活動所使用之特定商標及名稱，皆受相關知識產權法之保護，未經如新事先書面授權不得任意使用。

3. Eligibility to Purchase

In order to be eligible to purchase “ageLOC Boost™ Bouncy Bright Set” in this Program, you must be Brand Affiliate of Hong Kong or Macau who comply with the following requirements,

- Brand affiliates promoted to or maintain as the title of Brand Representative or above from 1st November to 1st December 2020, each brand affiliate account can order up to 3 sets of the “ageLOC Boost™ Bouncy Bright Set”

4. Purchasing Date and Time

- Brand Affiliates may place orders at Nu Town from 12:00 noon to 07:00 p.m. on 9th December, 2020 (applicable to Hong Kong brand affiliate) or at Macau Distribution Center (applicable to Macau brand affiliate) from 11:00 a.m. to 07:30 p.m. on 9th December, 2020

5. No Mandatory Purchase; Inventory and Retail Sales

- (a) You understand that the purchase of “ageLOC Boost™ Bouncy Bright Set” is optional, and there are no Bonuses paid for recruiting. Bonuses are paid only when “ageLOC Boost™ Bouncy Bright Set” are purchased and successfully delivered to you or collected by you, and you comply with the rules and requirements of the Sales Compensation Plan and Policies and Procedures of Nu Skin. In addition, please operate your Brand Affiliate Account in a financially responsible way. Please do not incur debt to participate in this Program or Nu Skin business.
- (b) You should order “ageLOC Boost™ Bouncy Bright Set” in accordance to your reasonably personal use or projected retail sales and the ordering not more than the above amount of personal use or

- (a) Subject to Clause 6(c) below and the Policies and Procedures of the Company, the Company will refund to you ninety percent (90%) of the purchase price less applicable bonus, on unopened and resalable for the products sold by the Company to you. The Company may also adjust your and your upline’s title with regard to such refund.
- (b) You must submit an application for the refund to the Company within 12 months from the date of purchase of “ageLOC Boost™ Bouncy Bright Set”.
- (c) You may return the whole set of “ageLOC Boost™ Bouncy Bright Set” or individual products in the “ageLOC Boost™ Bouncy Bright Set” provided that the returned product is unopened and resalable.

7. Purchase of “ageLOC Boost™ Bouncy Bright Set” on Other Brand Affiliate’s Account

You understand that if you order the “ageLOC Boost™ Bouncy Bright Set” through another Brand Affiliate Account, you must have obtained a validly signed Product Order/Credit Card Authorization Form from such Brand Affiliate and such Brand Affiliate agrees Nu Skin to collect, use and disclose his/her personal data and transfer his/her personal data to any third party or affiliated companies of Nu Skin in Hong Kong, Macau and outside of these areas for the purposes relating to this Program. 8. Pickup / Delivery

- (a) The “ageLOC Boost™ Bouncy Bright Set” you purchase on 9th December, 2020, you can choose pickup at Nu Skin Plaza or Mongkok Distribution Center (applicable to Hong Kong brand affiliate) or Macau Distribution Center (applicable to Macau brand affiliate) or delivery (applicable to Hong Kong market only) or collect the product via the EF Locker (applicable to Hong Kong market only).
- (b) Order will be delivered to the address in Hong Kong you provided or the EF Locker location you chose before 23th December 2020. Addresses of the Company, Nu Skin Plaza or distribution centers are considered as invalid shipping addresses. For those orders delivery to EF Locker, when the order arrives at EF Locker, you will receive a SMS notification from EF Locker. Please pick up your products in accordance to the instruction within the deadline as stated in the SMS. Please note that additional three (3) working days for delivery will be required for outlying islands or remote area in Hong Kong. You understand that if the delivery address provided by you in this

Program order page is invalid or the “ageLOC Boost™ Bouncy Bright Set” cannot be delivered to you after confirming the delivery date and time with you, the Company will contact you again to delivery arrangement but will charge you HK\$70 as the second delivery fee or the administrative fee for order amendment. If you choose to deliver the order to the EF Locker, you should pick up the products within 30 hours upon EF Locker sent you the SMS notification. If you fail to pick up the products on time, the products will be returned to the Company as unclaimed, the Company will contact you again for delivery arrangement but will charge you HK\$70 as the second delivery fee or as the administrative fee for order amendment. Please note that additional three (3) working days for delivery might be required for any change of delivery address. If the Company is unable to deliver the “ageLOC Boost™ Bouncy Bright Set” to your designated delivery address or within the selected date and time which has been confirmed by you within thirty (30) days from your order date due to an incorrect or incomplete delivery address or the unavailability of the named recipient at the address as provided by you or you fail to pick up the products within the timeslot states in the SMS from EF Locker, the Company will cancel your order of the “ageLOC Boost™ Bouncy Bright Set” and after deducting an administrative fee equivalent to ten percent (10%) of the purchase price, refund to you ninety percent (90%) of the purchase price less any bonus (if any). The Company will also adjust your title accordingly. For other terms relating to the refund policy, please also refer to Clause 6 above.

9. Limited Quantities, Purchase Limits

- (a) Limited Quantities. You acknowledge and agree that there is no guarantee that you will be able to purchase “ageLOC Boost™ Bouncy Bright Set” in this Program. Only a certain limited quantity of “ageLOC Boost™ Bouncy Bright Set” is available for sale in Hong Kong, and there may not be a sufficient quantity of “ageLOC Boost™ Bouncy Bright Set” to fulfill your order. All “ageLOC Boost™ Bouncy Bright Set” are offered while stock last.
- (b) Purchase Limits. You acknowledge and agree that the purchase of “ageLOC Boost™ Bouncy Bright Set” for this Program is strictly limited to quota assigned to qualified Brand Affiliate Account.

10. Order Procedures and Payment Methods

- (a) Order. To order “ageLOC Boost™ Bouncy Bright Set”, please login Nu Town (applicable to Hong Kong brand affiliate) or go to Macau Distribution Center (applicable to Macau brand affiliate).
- (b) Currency and Credit Card Authorization. The price of “ageLOC Boost™ Bouncy Bright Set” is in Hong Kong dollars. If you use a credit card for payment, you authorize the Company to charge your designated credit card for the full amount of the ordered “ageLOC Boost™ Bouncy Bright Set” and other related fees and charges, including shipping fees. If the Company is unable to charge the related amount from your designated credit card, the Company will cancel your order without notice. If you have chosen to pay for your purchases using a credit card not issued to you, you confirm that the holder to whom such credit card has been issued (the “Cardholder”) has consented to such use of the credit card and that the Cardholder has signified such consent by written consent. You also confirm that the Cardholder has agreed that Nu Skin may collect, use and disclose his/her personal data in the Limited Time Offer for the purpose of administration in relation to the matters referred to herein.
- (c) You acknowledge and agree that if the purchase of “ageLOC Boost™ Bouncy Bright Set” is paid by a third party’s credit card, the Company will deem you as the purchaser.

11. Collection of Personal Information

The Company respects your privacy and is committed to protecting it. You have the right to access and verify your personal information held by the Company by contacting the call center for your Resident Market. By placing an order of “ageLOC Boost™ Bouncy Bright Set” in this Program, you agree that your personal information may be collected, used and disclosed by the Company to its affiliates, suppliers and other service providers for this Program and for providing you the relevant services of “ageLOC Boost™ Bouncy Bright Set”, including but not limited to providing products, payment process, delivery arrangement, refund, management of your account and records, marketing promotion and research, data analysis and for other purposes set out in the Section 2, Chapter 1 of the Policies and Procedures. If your personal data has been changed, you will notify the Company immediately. All personal information access or correction requests and enquires regarding the Company’s privacy policy can be made via telephone at (852) 28377700. The Company has the right to charge a reasonable fee for the processing of your request.

12. Importation of “ageLOC Boost™ Bouncy Bright Set”

Neither we nor our affiliates assure that recipients of “ageLOC Boost™ Bouncy Bright Set” shall be able to import into any country. **IN PARTICULAR, SALE OR EXPORT OF “AGELOC BOOST™ BOUNCY BRIGHT SET” IN OR TO THE TAIWAN MARKET IS STRICTLY PROHIBITED.** Purchasers or recipients of “ageLOC Boost™ Bouncy Bright Set” are personally responsible for complying with all applicable import, customs and licensing laws and regulations and for all customs duties, taxes, licensing fees, declarations and any other costs, fees and expenses associated with their importation of the “ageLOC Boost™ Bouncy Bright Set” into their markets.
