

Terms and Conditions of S3 Scoring Contest

1. The participant should sign the “Authorisation Letter of Shared Information”.
2. Your original ID card and Certificate of Eligibility must be presented before each scan. Photocopies are not accepted.
3. The first 800 winners are entitled to a box of ageLOC® R² or 2 bottles of Marine Omega. Macau distributors should come to Causeway Bay Nu Skin Plaza collecting the ageLOC® R².
If participants importing ageLOC® R² to Macau, they should be responsible for complying with all applicable import and customs laws and regulations. If a participant has any questions on customs requirements, he/she should contact the relevant Government authority.
4. NU SKIN will verify your eligibility after you achieve your target. The participant must be eligible to join the contest, otherwise they will be disqualified from the prizes even if they achieve the targets.
5. The scanner scores you got at the venue shall be the qualifying data, and cannot be replaced by any other result.
