

Special Terms and Conditions of Purchase of ageLOC® TR90® V Kit (Applicable to Macau Distributors)

1. From February 6, 2015 to February 28, 2015, upon purchase of every ageLOC® TR90® V Kit (which includes 1 unit of ageLOC® TR90® product ("TR90 Kit") and 3 units of ageLOC® R² product ("R²") (collectively, "V Kit"), Distributors are entitled to receive 2 boxes of complimentary ageLOC® TR90® TRIMSHAKE® product ("TRIMSHAKE®").
2. The complimentary TRIMSHAKE® is non-returnable, non-refundable and does not contain PSV.
3. You can order V Kit online or by fax, telephone or visiting Nu Skin Plaza in Causeway Bay, Hong Kong, but it is not applicable to ARO order.
4. The Company does **not provide delivery service for Macau**. If you order your V Kit online, you may not collect the products you have ordered and the complimentary TRIMSHAKE® in person but they will only be delivered to the Hong Kong address you have provided during your order. If you order your V Kit by methods other than online, you can choose to (a) collect **the full set of** the V Kit products and the complimentary TRIMSHAKE® at Nu Skin Plaza in Causeway Bay, Hong Kong, or (b) first collect **JumpStart and R² products** at Nu Skin Plaza in Causeway Bay, Hong Kong and then collect the **rest** of the V kit products (including the complimentary TRIMSHAKE®) at Macau Distribution Center upon presentation of the original sales receipt, or (c) have the full set of the V Kit products and the complimentary TRIMSHAKE® delivered to the Hong Kong address you have provided during your order.
5. **Products can only be returned in person at Nu Skin Plaza in Causeway Bay, Hong Kong.** You may return the entire V Kit or only TR90 Kit or R² products within the V Kit if they are unopened and resalable. In such case, 2 boxes of complimentary TRIMSHAKE® must also be returned and must be unopened and resalable. If the 2 boxes of complimentary TRIMSHAKE® are not returned or cannot be returned in its original status because they have been opened, used, damaged, lost or otherwise, you must pay to the Company HK\$720 for each box of TRIMSHAKE®. Please note **individual products within TR90 Kit and R² are non-returnable and non-refundable**. Other terms and conditions in relation to product refunds and exchanges shall be governed by and construed in accordance with the Policies and Procedures of the Company.
6. In case of any inconsistency of the above special terms and conditions and the Policies and Procedures of Nu Skin Hong Kong/Macau, the above special terms and conditions shall prevail.
