

PROCEDURES OF OPENING PERSONAL WEBSITE FOR SELLING NU SKIN PRODUCTS

PROCEDURE:

- **Step 1:** Brand Affiliate send a notification form to Compliance team of Nu Skin Vietnam to inform Nu Skin Vietnam of his intention to open his/her website for selling Nu Skin products. The below terms shall be an integral part of the application letter and shall form undertakings and commitments of the Brand Affiliate with regard to the opening and using of his/her own website.
- **Step 2:** Brand Affiliate registered his/her selling website with MoIT (Ministry of Industry and Trade).
- **Step 3:** Brand Affiliate notify NSVN that his/her selling website has completed the registration with MOIT and is ready for selling Nu Skin products. Nu Skin Vietnam issue a “no comments” letter/email to Brand Affiliate.
- **Step 4:** Selling website goes live.

TERMS & CONDITIONS:

As a Brand Affiliate of Nu Skin Vietnam (“Company”), when opening, developing, maintaining and/or supporting, promoting any selling website by his/her own, the Brand Affiliate undertakes and agrees to be bound by the following obligations:

- a) To read, understand clearly and commit to comply with Nu Skin Social Selling Guidelines and other applicable guidelines issued and amended by Nu Skin Vietnam from time to time relating to the use of internet for promoting or selling Nu Skin products, Company Policies and Procedures, and applicable laws.

- b) To follow the procedures of opening the website which is primarily intended for selling Nu Skin products (“Personal Selling Website”).
- c) To be solely responsible for registering his/her Personal Selling Website with the Ministry of Industry and Trade (MOIT). The Company will not register his/her Personal Selling Website but may give him/her supporting documents for the registration as it deems necessary upon Brand Affiliate’s request.
- d) To ensure that all the descriptions and claims about Nu Skin products that are displayed on his/her Personal Selling Website must be identical and consistent with the descriptions and claims of the same products as published by Nu Skin Vietnam.
- e) To be solely responsible and ensure that his/her Personal Selling Website (including its contents and operation) complies with the undertakings and commitments mentioned therein, Nu Skin Social Selling Guidelines and other applicable guidelines (and its revisions) issued by the Company from time to time relating to the use of internet for promoting or selling Nu Skin products, Company Policies and Procedures, and applicable laws.

In the event of violation of the foregoing, (a) the Brand Affiliate will undertake all legal liabilities (including but not limited to compensating the victims and/or the Company for all their losses); and (b) the Company, at its sole discretion may require the Brand Affiliate to conduct any remedial action and/or remove all Nu Skin products and all information about Nu Skin from his/her Personal Selling Site and/or disable the visibility of his/her Personal Selling Site immediately; and (c) the Company may terminate the brand affiliate agreement with the Brand Affiliate immediately upon its sole discretion.
