

TERMS & CONDITIONS

ageLOC LUMISPA iO ROSE GOLD SYSTEM LAUNCH OFFER

The **ageLOC LUMISPA iO ROSE GOLD SYSTEM LAUNCH OFFER** (the “Promotion”) is subject to the following conditions:

1. The Promotion will only be valid from **Wednesday 24 January 2024, 10.00 AM CET until Wednesday 7 February 2024, 11.59 PM CET** and only for as long as promotional stocks last in the warehouse serving the relevant Participating Market (as defined below).

For the avoidance of doubt, this means that if the promotional stock of a certain SKU has been sold out in the warehouse serving a certain Participating Market, the Promotion will end in respect of the corresponding Promotional Product (as defined below) for that Participating Market. This will be the case even if there is still promotional stock of other Promotional Products available in said warehouse and the Promotion continues for those other Promotional Products in the same Participating Market, or if there is still Promotional Stock of the same SKU available in a different warehouse serving other Participating Markets and the Promotion continues for that SKU in those other Participating Markets.

The Promotion will be valid only for the following Nu Skin markets: Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Hungary, Iceland, Ireland, Italy, Luxembourg, the Netherlands, Norway, Poland, Portugal, Romania, Slovakia, South Africa, Spain, Sweden, Switzerland and United Kingdom (the “Participating Markets”).
