

## Nu Skin Special Offers Page TERMS & CONDITIONS

IMPORTANT: SOME OF THE PRODUCTS FEATURED ON THE SPECIAL OFFERS PAGE ARE SET TO EXPIRE WITHIN THE NEXT FOLLOWING MONTHS, BUT WILL HAVE AT LEAST TWO (2) REMAINING MONTHS OF SHELF LIFE AFTER YOUR PURCHASE.

The use of the Nu Skin Special Offers Page is subject to the following conditions:

- 1. The Special Offers Page of Nu Skin accessible at <a href="https://www.nuskin.com">https://www.nuskin.com</a> ("Special Offers Page") is a page that will be accessible periodically and feature products that are currently subject to a promotion (the "Products") and the discounts applicable to them (the "Discounts"). The Products listed on the Special Offers Page are of 4 types:
  - a. Previous versions of products that have transitioned or will transition to a new packaging or new formula
  - b. Products that have an approaching expiry date
  - c. Products or Nu Skin branded items that will be discontinued soon
  - d. Products or Nu Skin branded items that are currently promoted

The Special Offers Page will be regularly updated to include new Products. As soon as a Product is no longer subject to a Discount, it will be removed from the Special Offers Page.

- 2. There will be a separate Special Offers Page for each of the following Nu Skin EMEA markets (the "Nu Skin EMEA Markets"): Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Hungary, Iceland, Ireland, Italy, Luxembourg, the Netherlands, Norway, Poland, Portugal, Romania, Slovakia, South Africa, Spain, Sweden, Switzerland, United Kingdom. The Products featured on the Special Offers Page and the time during which they will be featured may vary from one Nu Skin EMEA Market to another. It may be possible that there is no current offer on a specific country.
- 3. The period during which the Discount will be applicable to the Products (the "Promotion Period") may vary from one Product to another. The Promotion Period for each Product will be specified on the local webpage of the corresponding Product (to access the local webpage of a specific Product, click on the Product on the Special Offers Page). All Promotion Periods will last only for as long as the Product's promotional stock lasts during the corresponding Promotion Period. For the avoidance of doubt, this means that if the stock for a specific SKU has been sold out, the applicable Discount will stop and the Product will be removed from the Special Offers Page for the relevant Nu Skin EMEA Market. This will be the case even if the end time of the Promotion Period, as indicated above, has not been reached yet.

<u>IMPORTANT</u>: Some of the Products are set to expire within the next following months, but will have at least a two-month shelf life after their purchase.

- 4. Depending on whether you are a Brand Affiliate/Member or Retail Customer, the Discount will apply to the Member Price or the Retail Price. This Discount will be applied automatically on the Products ordered via your local Special Offers Page, as well as through My Site and Product Offer. The Discount will not be available for orders placed via NLXX.
- 5. For Brand Affiliates, the Sharing Bonus, Sales Volume (SV) and Commissionable Sales Value (CSV) of the Products will be reduced accordingly during the corresponding Promotion Period. Brand Affiliates are advised to consult the pricelist.



- 6. The Discounts cannot be combined with or applied to any other sales, promotions, discounts, codes, coupons and/or special offers.
- 7. Products featured on the Special Offers Page can be added to an ADR order provided that the relevant ADR order runs during the Promotion Period subject to available stock (i.e., not at a date after the end of the Promotion Period or when stock is depleted, even if added to the order during the Promotion Period while there was still stock available). Any Product added to an ADR order will not generate any Product Points and it will not be possible to purchase such Products with ADR Product Points during the relevant Promotion Period. At the end of the Promotion Period or when stock is depleted, sales of the Products, other than those listed sub 1.d above, will be stopped with immediate effect and such Products will be removed automatically from any ADR orders.
- 8. Regular shipping and delivery costs will apply.
- 9. Nu Skin reserves the right to withdraw, amend or cancel the Special Offers Page and/or the Promotion Period and Discounts applicable to the Products at any time.
- 10. Nu Skin reserves the right to amend these Terms and Conditions at any time. Any revised version will be effective immediately when it is displayed on the website.
- 11. The original English version of these Terms and Conditions has been translated into other languages. In the event of any inconsistency or discrepancy between the English version and any other language version of these Terms and Conditions, the English version shall prevail.
- 12. These Terms and Conditions apply in addition to Nu Skin's General Conditions of Sale and/or the terms and conditions of your Member or Brand Affiliate Agreement, as the case may be. In case of any discrepancy or contradiction, the present Terms and Conditions will prevail in respect of the Special Offers Page.
