

OFFICIAL GIVE AWAY RULES:

1. In order to participate in the Give Away, a participant must fill out and mail in the Give Away form found [here](#). No purchase is necessary. However, an individual who purchases the Lunar New Year Package will be automatically entered in the Give Away. Ten (10) winners from the United States and ten (10) winners from Canada will be randomly selected and will receive a Pink LumiSpa (the "prize"). All Nu Skin customers, representatives, and affiliates in the United States and Canada are eligible to participate. Only one entry per participant.

2. The winners will be notified and the prize made available within a month of the Give Away's termination. The winners must accept the prize by email or Facebook messenger within one week of notification. Nu Skin is not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or a participant's failure to adequately monitor any electronic account.

Any winner notification not responded to or returned as undeliverable may result in prize forfeiture.
