



## PROP 65 WARNING FOR CONSUMERS IN CALIFORNIA

In 1986, California voters approved Proposition 65 (formally titled “The Safe Drinking Water and Toxic Enforcement Act of 1986). One of the most visible results of this act are the warning signs you see posted in eating establishments, airports, grocery stores and on a number of other commercially sold products. While the act remains quite controversial, most companies have chosen to post Proposition 65 warnings in their establishments or include warnings on product labels in cases where products may contain any of the listed chemicals.

Many of the substances on the list are naturally occurring in the environment, and when naturally occurring are exempt in natural levels from Proposition 65, however, it is very difficult to prove that the substances are naturally occurring. Some of these substances may accumulate in varying amounts, at different times, in different plants or animals in the supply chain. Natural products-including herbs, vitamins, minerals and other supplements, as well as many natural foods and cosmetics- are produced using ingredients and materials from the natural environment. Because of this, it is possible that some of the substances on the list may from time to time be present in these natural products—so we are including this warning in order to fall within a safe harbor provided under Prop 65.

To be fully compliant with Proposition 65 we included the relevant warning information on the product page of the Nu Skin website as well as on checkout page when specific products are being purchased by a customer with a California shipping address. A warning will also be included on the product packaging when sent to California residents. Proposition 65 is a law specific to the state of California and US Federal law has not banned or otherwise curtailed the common use of the listed chemicals, so the concentrations Nu Skin and the industries in general are using are believed to be safe. None the less, we are required to include a warning on the applicable product under Proposition 65 or discontinue selling the product in California.
