

2015 PACIFIC SUCCESS TRIP TERMS AND CONDITIONS

- 1. To qualify for any pin level you must meet all requirements of the Sales Compensation Plan, including retail sales. There are no bonuses paid for recruiting. All bonuses and commissions are paid only when qualifying products are shipped or delivered to you. For a complete summary of the Sales Compensation Plan, please go to www.nuskin.com.au (Australia) and www.nuskin.co.nz (New Zealand).
- 2. In order to qualify for the 2015 Pacific Success Trip, new Ruby through Blue Diamond Executives must complete a four (4) months (consecutive or non-consecutive) maintenance period between July 1st 2014 and June 30th 2015 as the newly advance Pin Title. During these qualifying four (4) months maintenance period the new Ruby through Blue Diamond Executive must maintain a minimum of 3000GSV every month.
- 3. Ever been Ruby through Diamond Executives may also participate in the 2015 Pacific Success Trip by advancing your highest pin title in the previous Pacific Success Trip qualification period (September 2013 August 2014). You must complete a four (4) months (consecutive or non-consecutive) maintenance period between July 1st 2014 and June 30th 2015 as the newly advance Pin Title. During these qualifying four (4) months maintenance period the newly advance Ruby through Diamond Executive must maintain a minimum of 3000GSV every month.
- 4. During the qualifying four (4) months maintenance period, should any of the first generation (G1) Executives of the qualifier Ruby to Blue Diamond Executive be titled as Provisional Executive (PEXEC) or Demoting Executive (DEXEC), the PEXEC/ DEXEC must have at least one downline maintained Executive each (regardless of generation depth) to be considered as an eligible first generation line.
- 5. Blue Diamond Executives who did not advance in pin title during the qualification period may qualify to attend the 2015 Pacific Success Trip by being paid as a Blue Diamond Executive for four (4) of the twelve (12) months qualifying period and have created a minimum of one (1) unencumbered new Star within their Generation one (1) to six (6) in their group who are also qualified to attend the 2015 Pacific Success Trip.
- 6. Pin Title advancement as a result of roll up will not count toward the qualifications.
- 7. In order to be eligible to participate in the Pacific Success Trip, your paid as title must not fall below Ruby title during any time from the 1st month you begin the qualifying four (4) months maintenance period between July 1st 2014 and June 30th 2015.
- 8. Any pin title advancement that is the result of an account merger will disqualify you from that particular 2015 Pacific Success Trip, i.e. if 2 accounts merge to create a Ruby Executiveship, the merged account would be disqualified from the new Ruby advancements, but could qualify for the Pacific Success Trip at the new Emerald, new Diamond and Blue Diamond advancements subject to the Terms and Conditions of the 2015 Pacific Success Trip.
- 9. The 2015 Pacific Success Trip is limited to a maximum of two participants per Distributorship (limited to Distributors who are named on the qualifying account on or prior to the qualification period, i.e. July 1st 2014, or an immediate family member of qualifying Distributor who is not a Distributor).
- 10. Executives with excessive returns of products in their organisation may be disqualified. Nu Skin Enterprises Australia, Inc. and Nu Skin Enterprises New Zealand, Inc. (collectively "Nu Skin Pacific") reserves the right, in its sole discretion, to determine what constitutes excessive returns. If there are any excessive returns in the twelve (12) months following the 2015 Pacific Success Trip that would have affected pin level and qualification for the 2015 Pacific Success Trip, then the Distributor agrees to reimburse the Nu Skin Pacific for the cost of the 2015 Pacific Success Trip and any other recognition events.
- 11. Distributors must not be in breach of Section 6.5, Chapter 2 of the Policies & Procedures. Any indication of manipulation regarding the qualification criteria will disqualify any Executive attempting to benefit from the action. This includes but is not limited to buying in volume for qualification purposes on down line accounts.
- 12. Nu Skin Pacific reserves the right to interpret the rules of the 2015 Pacific Success Trip.
- 13. Nu Skin Pacific has the final decision in the event of any disputes regarding any of the Terms and Conditions and Additional Rules.

ADDITIONAL RULES:

- Only new or ever been qualifiers (Ruby through Blue Diamond Executives) from markets within the Pacific Region (Australia, New Zealand, French Polynesia and New Caledonia) will be eliqible to participate in the Pacific Success Trip.
- To be eligible to participate in Pacific Success Trip, Breakaway Executives of the qualifiers for the qualification towards 2015 Pacific Success Trip have to be within Pacific Region (Australia, New Zealand, French Polynesia and New Caledonia).
- Nu Skin Pacific will allocate a flight allowance for return economy class flights to Thailand based on quotes from our choice of airline to arrive and depart for the dates of the trip from the closest capital city airport from the qualifiers' registered mailing address ("Flight Allowance"). Nu Skin Pacific will inform the qualifiers of the amount of Flight Allowance at the time qualification is met and qualifiers will be required to make their own flight bookings. Upon booking and paying for the flights, qualifiers shall submit a copy of the receipts to Nu Skin Pacific no later than August 31st 2015 and we will reimburse the qualifiers the actual amount paid, up to the maximum amount of the Flight Allowance. The reimbursement will be paid into the qualifiers' monthly commission in the following month after Nu Skin Pacific receives and approves the copy of the receipt. Any airline, location or date changes are at the qualifiers' expense and subject to Nu Skin Pacific's prior approval.

- If for whatever reason the qualifier did not attend the 2015 Pacific Success trip, the qualifier agree and hereby irrevocably authorise Nu Skin Pacific to recoup the Flight Allowance he/she received by deducting commission from the qualifier's distributor account any time, or by issuing a debit note to the qualifier for his/her settlement, or by any other means which Nu Skin deems appropriate.
- To participate in the 2015 Pacific Success Trip, all qualifiers and their guests MUST have their travel visas (if required) 3 weeks prior to the departure. Qualifiers and their guests are responsible for applying for their own visas.
- Nu Skin Pacific will pay for the costs of airfare, hotel, Nu Skin-organised group ground transportation, some meals and some amenities. Any additional costs will be the responsibility of the Qualifiers.
- No substitutes or cash equivalents will be awarded. The 2015 Pacific Success Trip is non-transferable. Trip cancellation by Qualifiers and/or their guests after official confirmation may incur costs to the Distributorship.
- Nu Skin Pacific and its affiliates (collectively "Nu Skin") reserve the right to withhold final approval on all qualifiers pending verification of compliance to the Terms and Conditions of 2015 Pacific Success Trip. Participants must be distributors in good standing with Nu Skin during the qualification period. Distributors found in non-compliance with the distributor contract during the qualification period may not participate.

PACKAGE INCLUDES:

- A five (5) day/ four (4) night trip for two (2) persons per distributorship.
- Roundtrip airfare to Thailand and ground transportation to and from hotel in Thailand and all organised activities for a maximum of two persons per distributorship. Local transportation to airport for departure/arrival is not included. Please note - complimentary round trip transportation to and from hotel in Thailand will be available ONLY on the 9th August 2015 and 13th August 2015. Any transfers outside of these dates will be the responsibility of the distributor at their own cost.
- Additional rooms may be arranged based on availability and at the expense of the qualifier.
- All meals indicated on the itinerary.
- All baggage handling if provided at the hotel.
- All hotel taxes and gratuities.
- Group activities as indicated on itinerary.

WHAT'S NOT INCLUDED THAT DISTRIBUTORS WILL HAVE TO PAY FOR?

- Any "free-time" activities or "optional" suggestions or tours, phone calls, laundry and any other hotel incidentals.
- Transportation to and from any events you choose to participate in other than what is included on the itinerary. We are not responsible for arranging transportation or transporting qualifiers and their guests to any outside events, including fly-ins.
- Transportation to and from hotel if arrival and/or departure dates are different from those indicated on itinerary.
- Meals not shown on itinerary.
- Any other expenses not specifically mentioned herein are not included.
- Applicable state, federal and local taxes.
- Travel Insurance is not included in the 2015 Pacific Success Trip. Qualifiers will need to make own arrangement if needed.

OTHER INFORMATION:

- If you cannot travel on dates specified, your participation in the 2015 Pacific Success Trip will be forfeited. You must attend the specific 2015 Pacific Success Trip you have qualified for.
- Taxes You will be responsible for applicable federal, state and local taxes, fees and any additional charges.
